## ORDINANCE NO. 3273

AN ORDINANCE relating to traffic control, limiting parking time to a 30-minute duration in five small areas in the vicinity of 16th Avenue SW and SW Roxbury Street, and amending King County Ordinance No. 1100, Schedule 17.

BE IT ORDAINED BY THE COUNCIL OF KING COUNTY:

SECTION 1. Pursuant to traffic engineering studies, and as authorized by King County Traffic Code 46.61.570-8 adopting RCW 46.61.570, Schedule 17 of KCC 46.61.570-8, which establishes a limit on parking time along county roads, is amended to add the following locations:

SW ROXBURY STREET, on the south side between 16th Avenue SW and 17th Avenue SW (4 parking spaces); parking time is limited to 30 minutes between the hours of 9 a.m. and 6 p.m. Mondays through Saturdays exclusively.

16th AVENUE SW on the west side from the south curb line of SW Roxbury Street to a point 80 feet south (2 parking spaces);—parking time is limited to 30 minutes between the hours of 9 a.m. and 6 p.m., Mondays through Saturdays exclusively.

16th AVENUE SW on the east side from the north curb line of SW 100th Street to a point 80 feet north (2 parking spaces); parking time is limited to 30 minutes between the hours of 9 a.m. and 6 p.m. Mondays through Saturdays exclusively.

16th AVENUE SW on the east side from the north curb line of SW 98th Street to a point 80 feet north (2 parking spaces); parking time is limited to 30 minutes between the hours of 9 a.m. and 6 p.m. Mondays through Saturdays exclusively.

16th AVENUE SW on the west side from the south curb line of SW 98th Street to a point 80 feet south (2 parking spaces); parking time is limited to 30 minutes between the hours of 9 a.m. and 6 p.m. Mondays through Saturdays exclusively.
