AN ORDINANCE relating to the 1977 Community Development Block Grant Program in the Maple Valley community, making a reappropriation of Community Development Block Grant Funds to provide \$547 additional funds for Health Clinic Services and \$4,048 additional funds for Community Center Support, returning \$905 to the County's Unallocated Population Fund, and authorizing the Executive to execute a contract.

## BE IT ORDAINED BY THE COUNCIL OF KING COUNTY:

## SECTION 1. FINDINGS

(a) In compliance with Ordinance No.2988 Section 55, as amended, which appropriated \$5,452,000 for the 1977 Community Development Block Grant Program, Motion No.2880 provided approval for certain projects which included the allocation of County Population Funds for:

CD-422-77 Maple Valley Health Clinic \$16,400 CD-442-77 Maple Valley Community Center \$23,100 CD-445-77 Maple Valley Transportation \$5,500

- (b) The Greater Maple Valley Community Center does not require the \$5,500 approved for transportation as they have received funding from a State of Washington supported grant.
- (c) The health services being provided by the Health Clinic justify an increase in the previously approved allocation in 1977 of \$16,400.
- (d) The Community Center Coordinator will have to devote substantial time for activities associated with the acquisition and construction of a permanent Maple Valley Community Center and the addition of a half-time person to sustain social service program planning would justify an increase in the Community Center allocation of \$23,100.
- (e) Assignment of a jurisdiction's Population funds require approval of the jurisdiction's legislative body.

(f) The withdrawal of the Transportation Program and the proposed reappropriation of funds is within the 10% budget deviation allowed in the Federal Regulations for which H.U.D. approval is not required for this action.

SECTION 2. There is hereby reappropriated from the Community Development Block Grant Fund the sum of \$547.00 to be added to CD-422-77, Maple Valley Health Center and the sum of \$4,048 to be added to CD-442-77, Maple Valley Community Center. Project CD-445-77, Maple Valley Transportation, is abrogated, and the residual sum of \$905.00 returned to the County's Unallocated Population Fund.

SECTION 3. The Executive is authorized to make the necessary contracts with the Maple Valley Community Center, implementing these appropriations, with the understanding that the County will not provide long-term program planning or maintenance and operation funds for the Center.
