## ORDINANCE NO. L 3336

AN ORDINANCE appropriating \$1,434,903, together with interest of \$396,409, to the County Road Fund from the unencumbered fund balance to reimburse the Arterial Highway Development Fund; and amending Ordinance No. 2988, Section 70, as amended.

## PREAMBLE:

From December 31, 1971 to December 31, 1972, \$1,434,903 of bond proceeds authorized by Resolution No. 34569, commonly referred to as the Forward Thrust Arterial Highway Improvement Bond Resolution, were transferred to the County Road Fund for expenditure on arterial highway improvements to twenty-six (26) highway projects. Such expenditures occurred prior to the passage of Ordinances Nos. 1016 and 1236. Both ordinances have been repealed by Ordinance No. 3310. It is, therefore, deemed appropriate that said bond proceeds of \$1,434,903, together with interest at a rate of 5% compounded quarterly, be transferred back to the Arterial Highway Development Fund.

BE IT ORDAINED BY THE COUNCIL OF KING COUNTY:

SECTION 1. There is hereby approved and adopted an appropriation of \$1,831,312 from the unencumbered fund balance of the County Road Fund for transfer to the Arterial Highway Development Fund No. 00336.

SECTION 2. Expenditures on the following projects are hereby reimbursed to the Arterial Highway Development Fund for expenses incurred on twenty-six (26) projects prior to the passage of Ordinance Nos. 1016 and 1236:

- 132nd Avenue N.E. and N.E. 120th Street from N.E. 60th Street to Slater Avenue N.E. 13 - 72
