10 ORDINANCE NO. 3360

11 AN ORDINANCE amending King County Zoning Resolution
12 No. 25789, as amended, by amending the Zoning Map thereof
13 reclassifying certain property thereon at the request of Ralph
14 Olsen, Building and Land Development Division File No. 129-77-R.

15 BE IT ORDAINED BY THE COUNCIL OF KING COUNTY:

16 SECTION 1. Ralph Olsen petitioned on March 16, 1977, that the property de-
17 scribed in Section 3 below be reclassified from G (Potential ML) to ML and this
18 application was assigned Building and Land Development Division File No. 129-77-R.

19 SECTION 2. The report and recommendation of the Building and Land Develop-
20 ment Division was transmitted to the Zoning and Subdivision Examiner on
21 May 3, 1977, and hearing was held by the Examiner on the matter May 10, 1977.
22 The report of the Examiner was filed with the Clerk of the King County Council on
23 June 2, 1977, and the Council approved the reclassification by Motion No. 3060
24 on June 6, 1977, subject to conditions which will be satisfied per the "P" suffix.

25 SECTION 3. The legal description of the property to be reclassified is attached
26 as Appendix A and is hereby made a part of this ordinance. The above described
27 property is shown on the attached map which is designated Appendix B and is hereby
28 made a part of this ordinance.

29 SECTION 4. The King County Council does hereby amend King County Zoning
30 Code, Resolution No. 25789, as amended, by reclassifying certain property described
31 and shown in Section 3, Appendices A and B above, to M-P and

1 directs that Area Map 6-22-3 be modified to so designate.

2 SECTION 5. This reclassification is granted subject to conditions adopted in
3 Motion No. 3060 and said conditions are incorporated herein as though fully set
4 forth herein.



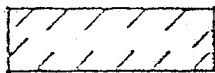
OVERALL LEGAL DESCRIPTION:
