ORDINANCE NO. 3362

AN ORDINANCE relating to the annexation of an area known as Annexation No. 42 to Northeast Lake Washington Sewer District.

STATEMENT OF FACT:

1. A notice of intention proposing the annexation of an area known as Annexation No. 42 to Northeast Lake Washington Sewer District was filed with the County Council effective June 29, 1977.

2. Northeast Lake Washington Sewer District has found the petition for annexation to be sufficient and has, by Resolutions 77-6-4 and 77-5-7, concurred with the proposed annexation.

3. Northeast Lake Washington Sewer District filed a Declaration of Nonsignificant Impact dated June 2, 1977, on the proposed annexation.

4. The County Council held a public hearing on the 22nd day of August, 1977, and has considered the criteria set forth in RCW 56.02.060.

BE IT ORDAINED BY THE COUNCIL OF KING COUNTY:

SECTION 1. The annexation by Northeast Lake Washington Sewer District of the area known as Annexation No. 42 and described in Section 2 herein is approved.

SECTION 2. The area known as Annexation No. 42 to be annexed is described as follows:

Beginning at the intersection of the East line of the Southwest $\frac{1}{4}$ of the SE $\frac{1}{4}$ of Section 28, Township 26 N., Range 5 E., W.M. and the centerline of NE 120th Street and true point of beginning;

Thence South along the East line of said Southwest $\frac{1}{4}$ to its intersection with a line which is 200' North of and parallel to the South line of the North $\frac{1}{2}$ of the said Southwest $\frac{1}{4}$;

Thence Westerly along said line which is 200' North of and parallel with the South line of the North $\frac{1}{2}$ of said Southwest $\frac{1}{4}$ to its intersection with the centerline of Slater Avenue Northeast;

Thence Northeasterly along the said centerline of Slater Avenue Northeast to its intersection with the centerline of Northeast 120th Street;

Thence Easterly along the said centerline of Northeast 120th Street to its intersection with the East line of the Southwest $\frac{1}{4}$ of the Southeast $\frac{1}{4}$ of said Section 28 and true point of beginning.

All of the above described area is within King County, Washington.
