AN ORDINANCE relating to the dissolution of King County Water District No. 61.

3

STATEMENT OF FACT:

- 1. A notice of intention proposing the conveyance of the water system of King County Water District No. 61 to the City of Seattle, as authorized by RCW 57.08.020 57.08.040, and the dissolution of King County Water District No. 61 pursuant to RCW 57.04.090 and RCW 53. 48.010 was filed with the County effective June 29, 1977.
- 2. King County Water District No. 61 has filed a Declaration of Environmental Nonsignificance on the proposed dissolution, dated June 3, 1977.
- 3. It has been determined by the district that, following conveyance of the water system to the City of Seattle, the continued existance of King County Water District No. 61 will be unnecessary.
- 4. In addition to providing water services, King County Water District No. 61 also provides street lighting services throughout the district. The district is investigating several possibilities for continuation of this service following dissolution.
- 5. The County Council held a public hearing on the 29 day of August, 1971 and has considered the criteria set forth in RCW 56.02.060.

SECTION 1. The dissolution of King County Water District No. 61 as described in Section 2 herein is approved, subject to the conveyance of the water system of King County Water District No. 61 to the City of Seattle, and PROVIDED THAT adequate provisions are developed for the continuation of street lighting services within the district.

SECTION 2. King County Water District No. 61 to be dissolved is described as follows:

Section 1, Township 23 North, Range 3 East, W.M.; all except the West half of the West half,

Section 6, Township 23 North, Range 4 East, W.M.; Northwest quarter except the South three quarters of the Southeast quarter of said Northwest quarter,

Section 6, Township 23 North, Range 4 East, W.M.; Southwest quarter of the Southeast quarter,

Section 6, Township 23 North, Range 4 East, W.M.; Southwest quarter except the Northeast quarter of the Southwest quarter.

Section 12, Township 23 North, Range 3 East, W.M.; That portion lying Easterly of 30th Avenue Southeast and Seola Beach Drive and Easterly of Puget Sound,

Section 7, Township 23 North, Range 4 East, W.M.; Northwest half,
