ORDINANCE NO. 3444

AN ORDINANCE relating to the annexation of an area known as Annexation #41 to Northeast Lake Washington Sewer District.

STATEMENT OF FACT:

1. A notice of intention proposing the annexation of an area known as Annexation #41 to Northeast Lake Washington Sewer District was filed with the County Council effective December 3, 1976.

2. Northeast Lake Washington Sewer District has found the petition for annexation to be sufficient and has, by Resolution 76-10-9, concurred with the proposed annexation.

3. Northeast Lake Washington Sewer District filed a Declaration of Nonsignificant Impact dated November 11, 1976, on the proposed annexation.

4. The County Council held a public hearing on the 10th day of October, 1977, and has considered the criteria set forth in RCW 56.02.060.

BE IT ORDAINED BY THE COUNCIL OF KING COUNTY:

SECTION 1. The annexation by Northeast Lake Washington Sewer District of the area known as Annexation #41 and described in Section 2 herein is approved.

SECTION 2. The area known as Annexation #41 to be annexed is described as follows:

Commencing at the Southwest corner of Section 17, Township 26 North, Range 5 East, W.M., King County, Washington;

Thence Northerly in and along the West line of said Section 17 to Southwest corner of the Northwest quarter of the Northwest quarter of the Southwest quarter of said Section 17 and TPOB: thence continue Northerly in and along the said West line of Section 17 to the Northwest corner of the Southwest quarter of the Northwest quarter of said Section 17;

Thence Easterly in and along the North line of said subdivision to the East line of the West half of the West half of said Section 17;

Thence Southerly in and along the said East line of said subdivision to the South line of the Northwest quarter of the Southwest quarter said Section 17;

Thence Westerly in and along the South line of Northwest quarter of the Southwest quarter said Section 17, to the Southwest corner of the Southeast quarter of the Northwest quarter of the Southwest quarter of said Section 17;
