ORDINANCE NO.

3446

AN ORDINANCE relating to the annexation of an area known as Rustic Village II to Lakehaven Sewer District.

STATEMENT OF FACT:

- 1. A notice of intention proposing the annexation of an area known as Rustic Village II to Lakehaven Sewer District was filed with the County Council effective August 16, 1977.
- 2. Lakehaven Sewer District has found the petition for annexation to be sufficient and has, by Resolution 77-529, concurred with the proposed annexation.
- 3. Lakehaven Sewer District filed a Declaration of Nonsignificant Impact dated July 21, 1977, on the proposed annexation.
- 4. The County Council held a public hearing on the day of october, 1977, and has considered the criteria set forth in RCW 56.02.060.

BE IT ORDAINED BY THE COUNCIL OF KING COUNTY:

SECTION 1. The annexation by Lakehaven Sewer District of the area known as Rustic Village II and described in Section 2 herein is approved.

SECTION 2. The area known as Rustic Village II to be annexed is described as follows:

Beginning at the intersection of the South line of Section 33, Township 22 North, Range 4 East, W.M., in King County, Washington (said line also being the centerline of South 288th Street) and the Southerly prolongation of the Westerly line of the plat of Rustic Village as recorded in Volume 65 of Plats, page 47 - 48, records of King County, Washington;

Thence Northerly along said Westerly line and its Southerly prolongation to an intersection with the Southerly line of the plat of Noffsingers Second Addition as recorded in Volume 75 of Plats, page 93, records of King County, Washington;

Thence Westerly along said South line and its Westerly prolongation to an intersection with the centerline of Military Road;

Thence Northeasterly along said centerline of Military Road to its intersection with the East margin of Interstate Highway No. 5;

Thence Southerly along the East margin of said Interstate Highway No. 5 to its intersection with the East line of said Section 33 (also being the West line of Section 34)
