AN ORDINANCE amending King County Zoning Code, Resolution No. 25789, as amended, by amending the Zoning Map thereof adopting a Final Planned Unit Development on certain property thereon at the request of 1001 Club, Inc., Building and Land Development Division File No. 210-75-P.
