3457 ORDINANCE NO.

AN ORDINANCE amending King County Zoning Resolution No. 25789, as amended, by amending the Zoning Map thereof reclassifying certain property thereon at the request of Floyd F. Klinkenberg, et al, Building and Land Development Division File No. 105-77-R.

BE IT ORDAINED BY THE COUNCIL OF KING COUNTY:

SECTION 1. Floyd F. Klinkenberg, et al petitioned on November 12, 1976, that property described in Section 3 below be reclassified from SR to RM-900-P and this application was assigned Building and Land Development Division File No. 105-77-R.

SECTION 2. The report and recommendation of Building and Land Development Division was transmitted to the Zoning and Subdivision Examiner on January 3, 1977, and hearing was held by the Examiner on the matter January 11, 1977. The report of the Examiner was filed with the Clerk of the King County Council on February 2, 1977, and the Council approved the reclassification by Motion No. 2994 on May 2, 1977 and modified by Motion No 3089 on June 27, 1977, subject to conditions which will be satisfied per the "P" suffix.

SECTION 3. The legal description of the property to be reclassified is attached as Appendix A and is hereby made a part of this ordinance. The above described property is shown on the attached map which is designated Appendix B and is hereby made a part of this ordinance.

SECTION 4. The King County Council does hereby amend King County Zoning Code, Resolution No. 25789, as amended, by reclassifying that property described and shown in Section 3, Appendices A and B above, to RM-900-P and

OVERALL LEGAL DESCRIPTION:

Portion of the Northeast quarter of the Southwest quarter of Section 10, Township 26 North, Range 5 East, W.M., described as follows:

Beginning at a point 446 feet West and 30 feet South of the Northeast corner of said subdivision; thence South 2 degrees 48'27" East 625.7 feet, more or less, to the North line of a tract of land deeded to Theodore L. Calkins; thence South 88°22'26" West along the North line of said Clakins Tract and said line produced 325 feet to the point of beginning; thence North 88°22'26" East 120.8 feet, more or less, to the Northwest corner of said Calkins Tract; thence South 2 degrees 23'38" East along the West line of said Calkins Tract 656.6 feet, more or less, to the Southwest corner of said Tract; thence South 88°23'58" West 278.4 feet, more or less, to the Southeast corner of a tract of land deeded to Authur E.
