ORDINANCE NO. 3460

AN ORDINANCE authorizing condemnation of property for additions to and improvements of Boeing Field/King County International Airport West Side Site.

- 1. The King County Council on November 24, 1976, by Ordinance No. 2988, and as amended, did adopt the 1977 Annual Budget for King County, and did provide therein for the Capital Budget and Program, which included a Boeing Field/King County International Airport Capital Improvement Program.
- 2. The King County International Airport Capital Improvement Program provides for certain capital additions and improvements be made to the "King County Airport," the structures and property incidental to its operation.
- 3. The King County Council on November 15, 1976, by Ordinance No. 2972, did adopt a plan and system for implementing the capital additions and improvements which included the acquisition of all necessary property, easements, rights of way and permits for the development of and improvement to the "King County Airport" West Side Site.
- 4. In order to acquire the property and property rights required to lay out and construct additions to, and improve the West Side Site at the "King County Airport," it is necessary for King County to condemn certain lands and property rights and rights in property for public purposes as hereinafter more particularly set forth.
- 5. The King County Council finds that the public health, safety, necessity, convenience and welfare demand that the West Side Site and appurtenances be constructed in accordance with the Capital Budget and Program and King County Ordinance No. 2972. The King County Council further finds that certain properties, property rights and rights in property be condemned, appropriated, taken and damaged for the construction of said West Side Site, as provided in this ordinance.

BE IT ORDAINED BY THE COUNCIL OF KING COUNTY:

SECTION 1. The King County Council has deemed it necessary and in the best interest of the citizens of King County that the lands hereinafter described, and other property rights and/or rights in property be condemned, appropriated, taken and damaged for the purpose of constructing the West

Side Site at the "King County Airport," subject to the making or paying of just compensation to the owners thereof in the manner provided by law.

That portion of Francis McNatt Donation Claim No. 38, Section 33, Township 24 North, Range 4 East, W.M., in King County, Washington described as follows: BEGINNING at a point on the east margin of East Marginal Way, which point bears N.89°15'54" W. 2,360.19 ft. along the Donation Claim line and S.23°40'59" E. 895.56 ft. along the east line of East Marginal Way from the intersection of the line between the Donation Claim of Francis McNatt and Henry Van Asselt with the east line of Sec. 33, Twp 24 N., Rge 4 E., W.M., in King County, Washington; thence continuing S.23°40'59" E. 349.13 ft. to the true point of beginning; thence south continuing 23°40'59" E. 129.06 ft. to the north line of a tract of land conveyed by James F. centerline of said East Marginal Way, a distance of 358.512 ft. to the true point of beginning, which point is N.23°40'59" West 135.01 ft. from the intersection of said easterly margin of East Marginal Way and the westerly margin of Purcell Ave. South, formerly Duwamish Avenue, produced southerly, said point of beginning being point of curve having a radius of 56.623 ft.; thence easterly along said curve 132.91 ft. to the point of tangency on the westerly margin of said Purcell Ave. South, formerly Duwamish Avenue; thence N.21°49'20" E. along said westerly margin of Purcell Ave. South 105.60 ft.; thence N.81°21'04" W. 203.12 ft. to said easterly margin of East Marginal Way; thence S.23°40'59" E. 142.25 ft. to the true point of beginning.

PARCEL NO. 11 - ARCHER BLOWER

A portion of the Timothy Grow Donation Claim No. 48, in Section 33, Township 24 North, Range 4 East, W.M., in King County, Washington, described as follows: BEGINNING at the intersection of the most easterly line of Primary State Highway No. 1, (also known as East Marginal Way), with the south line of said Sec. 33; thence N.66°17'15" E., at right angles to said line of said highway, 145.00 ft. to the true point of beginning; thence N.19°41'25" W. 188.00 ft.; thence N.86°56'15" W. 119.53 ft. to the southeasterly line of Purcell Avenue; thence along said southeasterly line, N.21°48'03" E. 217.51 ft. to the north line of said Timothy Grow Donation Claim No. 48; thence N.88°57'57" E., along said north line, 394.41 ft. to the southwesterly line of addition to Boeing Field King County Airport as fixed and described in King County Superior Court Cause No. 426208; thence
