3469

AN ORDINANCE relating to the annexation of an area known as Pacific to King County Water District No. 124; repealing Ordinance 3363, Section 2, and adding a new Section.

BE IT ORDAINED BY THE COUNCIL OF KING COUNTY:

SECTION 1. Ordinance 3363, Section 2 is hereby repealed.

NEW SECTION. SECTION 2. The area known as Pacific to be annexed to King County Water District No. 124 is described as follows:

That portion of the West half of Section 35, Township 21 North, Range 4 East, W.M.; described as follows:

Beginning at the Southwest corner of said Section 35, thence Northerly along the West line thereof to its intersection with the North line of the South half of the Northwest quarter of said Section 35;

Thence Easterly along said North line to its intersection with a line which is 120 feet Easterly of and parallel with the West line of Lot 8, Block 18, of C.D. Hillman's Pacific City Addition to City of Seattle, Division No. 1, according to plat thereof recorded in volume 13 of plats, page 64, records of King County, Washington;

Thence Southerly along said parallel line to its intersection with the South line of said Lot 8;

Thence Westerly along said South line to the Northeast corner of Lot 5 said Block 18;

Thence Southerly along the East line of said Lot 5 a distance of 100 feet;

Thence Southwesterly to the intersection of the East line of Lot 4 said Block 18, with a line 150 feet Northerly of and parallel with the South line of said Lot 4;

Thence Westerly along said parallel line to its intersection with the West line of said Lot 4;

Thence Southerly along said West line to the Southeast corner of Lot 3 said Block 18;

Thence Westerly along the South line of said Lot 3 to its intersection with the Northerly extension of the West line of Lot 11 Block 17 said C.D. Hillman's Pacific City Addition to City of Seattle, Division No. 1;

Thence Southerly along said Northerly extension and the West line of said Lot 11, to its intersection with a line which is 150 feet Southerly of and parallel with the North line of said Lot 11;

Thence Southerly along said West line to the Northwest corner of Lot 5 said Block 17;

Thence Easterly along the North line of said Lot 5 to the Northeast corner thereof;

Thence Southerly along the East line of said Lot 5 to the Northwest corner of Lot 6 said Block 17;

Thence Easterly along the North line of said Lot 6 a distance of 240 feet;

Thence Southerly to a point on the South line of said Lot 6 which is 275 feet from the Southwest corner thereof;

Thence Southerly at right angles to the South line of said Lot 6, a distance of 30 feet to the North line of the South half of the Southwest quarter of said Section 35;

Thence Westerly along said North line to a point which is 350 feet Easterly of the West line of the East half of the said Southwest quarter;

Thence Southerly to a point on the North line of the South half of the South half of the said Southwest quarter which is 450 feet Easterly (as measured along said North line) of the said West line of the East half of the Southwest quarter;
