ORDINANCE NO. 3491

AN ORDINANCE relating to the annexation of an area known as Talbot to King County Water District No. 58.

STATEMENT OF FACT:

1. A notice of intention proposing the annexation of an area known as Talbot to King County Water District No. 58 was filed with the County Council effective October 25, 1977.

2. King County Water District No. 58 has found the petition for annexation to be sufficient and has, by Resolutions 1610 and 1611, concurred with the proposed annexation.

3. King County Water District No. 58 filed a Declaration of Nonsignificant Impact dated July 29, 1977, on the proposed annexation.

4. The County Council held a public hearing on the 14th day of November, 1977, and has considered the criteria set forth in RCW 57.02.040.

BE IT ORDAINED BY THE COUNCIL OF KING COUNTY:

SECTION 1. The annexation by King County Water District No. 58 of the area known as Talbot and described in Section 2 herein is approved.

SECTION 2. The area known as Talbot to be annexed is described as follows:

Beginning at the intersection of the South line of the North quarter of the South half of the Southeast quarter of the Northeast quarter of Section 3, Township 22 North, Range 5 East, W.M. with the East line of the Southwest quarter of the Northeast quarter of said Section 3, said point being on the existing boundary of Water District No. 58;

Thence Southerly along the East line of the Southwest quarter of the Northeast quarter to the East-West centerline of said Section 3;

Thence continuing Southerly along the West line of the Northeast quarter of the Southeast quarter of said Section 3 to the Southwest corner thereof;

Thence Easterly along the South line of said Northeast quarter to the East line of the West half of the West half of the Northeast quarter of the Southeast quarter of said Section 3;

Thence Northerly along said East line to the East-West centerline of said Section 3;

Thence Easterly along said East-West centerline to the West line of the East 880 feet of the Southeast quarter of the Northeast quarter of said Section 3;
