ORDINANCE NO.

3509

AN ORDINANCE relating to the annexation of an area known as South 130th Street to Val Vue Sewer District.

STATEMENT OF FACT:

- 1. A notice of intention proposing the annexation of an area known as South 130th Street to Val Vue Sewer District was filed with the County Council effective November 4, 1977.
- 2. Val Vue Sewer District has found the petition for annexation to be sufficient and has, by Resolution 791, concurred with the proposed annexation.
- 3. Val Vue Sewer District filed a Declaration of Nonsignificant Impact dated October 18, 1977, on the proposed annexation.
- 4. The County Council held a public hearing on the 5th day of <u>Secender</u>, 19<u>77</u>, and has considered the criteria set forth in RCW 56.02.060.

BE IT ORDAINED BY THE COUNCIL OF KING COUNTY:

SECTION 1. The annexation by Val Vue Sewer District of the area known as South 130th Street and described in Section 2 herein is approved.

SECTION 2. The area known as South 130th Street to be annexed is described as follows:

A portion of the Northwest quarter of Section 15, Township 23 North, Range 4 East, W.M. in King County, Washington, described as follows:

Beginning at the centerline intersection of 32nd Avenue South and South 130th Street; Thence Northeasterly along the centerline of South 130th Street to the centerline of Pacific Highway South (SR-1); Thence Southeasterly along the centerline of Pacific Highway South to the Northeasterly extension of the Southeasterly line of Lot 8, Block 7, Robbins Spring Brook Addition to Riverton as recorded in Volume 16 of Plats, page 57, Records of King County, Washington;

Thence Southwesterly along said extension and along the Southeasterly line of said Lot 8 to the centerline of the alley through said Block 7; Thence Southeasterly along the centerline of said alley to the Northeasterly extension of the Southeasterly line of Lot 17 in said Block 7; Thence Southwesterly along said extension and along the Southeasterly line of said Lot 17 and along the Southwesterly production of said line to the centerline of 34th Avenue South;
