ORDINANCE NO. 3518

AN ORDINANCE relating to the annexation of an area known as Annexation #46 to Northeast Lake Washington Sewer District.

STATEMENT OF FACT:

1. A notice of intention proposing the annexation of an area known as Annexation #46 to Northeast Lake Washington Sewer District was filed with the County Council effective November 11, 1977.

2. Northeast Lake Washington Sewer District has found the petition for annexation to be sufficient and has, by Resolution 77-9-13, concurred with the proposed annexation.

3. Northeast Lake Washington Sewer District filed a Declaration of Nonsignificant Impact dated October 21, 1977, on the proposed annexation.

4. The County Council held a public hearing on the 12<sup>th</sup> day of December, 1977, and has considered the criteria set forth in RCW 56.02.060.

BE IT ORDAINED BY THE COUNCIL OF KING COUNTY:

SECTION 1. The annexation by Northeast Lake Washington Sewer District of the area known as Annexation #46 and described in Section 2 herein is approved.

SECTION 2. The area known as Annexation #46 to be annexed is described as follows:

Beginning at the Southeast corner of the SE  $\frac{1}{4}$  of the NE  $\frac{1}{4}$  of Section 24, Township 26 North, Range 4 East, W.M., King County, Washington, and true point of beginning;

Thence Westerly along the East-West centerline of said Section 24 to the Southwest corner of said SE  $\frac{1}{4}$  of the NE  $\frac{1}{4}$  of said Section 24;

Thence Northerly along the West line of said SE  $\frac{1}{4}$  to its intersection with the North margin of NE 141st Street;

Thence Easterly along said North margin, also being the South margin of the Plat of Shamrock Village as recorded in Vol. 84, Page 73, Records of King County, Washington, to the Southeast corner of said plat;

Thence Northerly along the East line of the said Plat of Shamrock Village to its intersection with the South line of the Plat of Serene Vista No. 2 as recorded in Vol. 89, Page 27, Records of King County, Washington;

Thence Easterly along the South line of the said Plat of Serene Vista No. 2 and the Easterly Extension thereof to its intersection with the East line of the West  $\frac{1}{2}$  of the East  $\frac{1}{2}$  of the East  $\frac{1}{2}$  of said Section 24;

3 Thence Easterly along said Southerly margin of NE 141st  
4 Street and its Easterly extension to its intersection  
with the East line of said Section 24;

5 Thence Southerly along said East line of Said Section  
6 24 to the Southeast corner of the SE 1/4 of the NE 1/4 of  
said Section 24 and true point of beginning.
