AN ORDINANCE amending King County Zoning Resolution No. 25789, as amended, by amending the Zoning Map thereof reclassifying certain property thereon at the request of Sea-King Land Company, Building and Land Development Division File No. 147-76-R.

BE IT ORDAINED BY THE COUNCIL OF KING COUNTY:

SECTION 1. Sea-King Land Company petitioned on June 9, 1976, that the property described in Section 3 below be reclassified from RS-7200 (Potential RD-3600) to RD-3600 and this application was assigned Building and Land Development Division File No. 147-76-R.

SECTION 2. The report and recommendation of the Building and Land Development Division was transmitted to the Zoning and Subdivision Examiner on July 27, 1976, and hearing was held by the Examiner on the matter August 3, 1976. The report of the Examiner was filed with the Clerk of the King County Council on August 25, 1976, and the Council approved the reclassification by Motion No. 2663 on August 30, 1976, subject to conditions which have been satisfied.
