10 ORDINANCE NO. 3557

11 AN ORDINANCE amending King County Zoning Resolution
12 No. 25789, as amended, by amending the Zoning Map thereof
13 reclassifying certain property thereon at the request of
Sea-King Land Company, Building and Land Development
Division File No. 147-76-R.

14 BE IT ORDAINED BY THE COUNCIL OF KING COUNTY:

15 SECTION 1. Sea-King Land Company petitioned on June 9, 1976, that the
16 property described in Section 3 below be reclassified from RS-7200 (Potential
17 RD-3600) to RD-3600 and this application was assigned Building and Land
18 Development Division File No. 147-76-R.

19 SECTION 2. The report and recommendation of the Building and Land De-
20 velopment Division was transmitted to the Zoning and Subdivision Examiner on
21 July 27, 1976, and hearing was held by the Examiner on the matter August 3, 1976.
22 The report of the Examiner was filed with the Clerk of the King County Council
23 on August 25, 1976, and the Council approved the reclassification by Motion No.
24 2663 on August 30, 1976, subject to conditions which have been satisfied.

25 SECTION 3. The legal description of the property to be reclassified is attached
26 as Appendix A and is hereby made a part of this ordinance. The above described
27 property is shown on the attached map which is designated Appendix B and is hereby
28 made a part of this ordinance.

29 SECTION 4. The King County Council does hereby amend King County Zoning
30 Code, Resolution No. 25789, as amended, by reclassifying that property described
31 and shown in Section 3, Appendices A and B above, to RD-3600 and

directs that Area Map W 4-26-4 be modified to so designate.

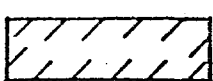
