9 ORDINANCE NO. 3560

10 AN ORDINANCE amending King County Zoning Resolution
11 No. 25789, as amended, by amending the Zoning Map thereof
12 reclassifying certain property thereon at the request of Aaron
13 L. Litowitz, Building and Land Development Division File
14 No. 262-74-R.

15 BE IT ORDAINED BY THE COUNCIL OF KING COUNTY:

16 SECTION 1. Aaron L. Litowitz petitioned on August 19, 1974, that the property
17 described in Section 3 below be reclassified from SE to M-P and this application
18 was assigned Building and Land Development Division File No. 262-74-R.

19 SECTION 2. The latest report and recommendation of the Building and Land
20 Development Division was transmitted to the Zoning and Subdivision Examiner on
21 August 16, 1977, and hearing was held by the Examiner on the matter August 23, 1977.
22 The report of the Examiner was filed with the Clerk of the King County Council on
23 September 16, 1977, and the Council approved the reclassification by Motion No.
24 3218 on September 26, 1977.

25 SECTION 3. The legal description of the property to be reclassified is attached
26 as Appendix A and is hereby made a part of this ordinance. The above described
27 property is shown on the attached map which is designated Appendix B and is
28 hereby made a part of this ordinance.

29 SECTION 4. The King County Council does hereby amend King County Zoning
30 Code, Resolution No. 25789, as amended, by reclassifying that property described
31 and shown in Section 3, Appendices A and B above, to A-O-U and


