AN ORDINANCE amending King County Zoning Resolution No. 25789, as amended, by amending the Zoning Map thereof reclassifying certain property thereon at the request of Quaker Properties, Inc., Building and Land Development Division File No. 152-77-R.

BE IT ORDAINED BY THE COUNCIL OF KING COUNTY:

SECTION 1. Quaker Properties, Inc. petitioned on June 14, 1977, that the property described in Section 3 below be reclassified from RS-7200 to RM-900 and this application was assigned Building and Land Development Division File No. 152-77-R.

SECTION 2. The report and recommendation of the Building and Land Development Division was transmitted to the Zoning and Subdivision Examiner on September 6, 1977, and hearing was held by the Examiner on the matter September 13, 1977. The report of the Examiner was filed with the Clerk of the King County Council on October 13, 1977, and the Council approved the reclassification by Motion No. 3295 on November 14, 1977, subject to conditions which will be satisfied per the "P" suffix.

SECTION 3. The legal description of the property to be reclassified is attached as Appendix A and is hereby made a part of this ordinance. The above described property is shown on the attached map which is designated Appendix B and is hereby made a part of this ordinance.
