AN ORDINANCE amending King County Zoning Code, Resolution No. 25789, as amended, by amending the Zoning Map thereof adopting an Unclassified Use Permit on certain property thereon at the request of Art McCann and Sons, Inc, Building and Land Development Division File No. 217-77-U.

BE IT ORDAINED BY THE COUNCIL OF KING COUNTY:

SECTION 1. Art McCann & Sons, Inc., petitioned on January 27, 1977, for an Unclassified Use Permit to allow the removal of sand and gravel on property described in Section 3 below and this application was assigned Building and Land Development Division File No. 217-77-U.

SECTION 2. The report and recommendation of the Division of Building and Land Development was transmitted to the Zoning and Subdivision Examiner on April 5, 1977, and hearings were held by the Examiner on the matter on March 22, 1977. April 12, 1977 and July 14, 1977. The report of the Examiner was filed with the Clerk of the King County Council on October 27, 1977, and the Council approved the reclassification by Motion No. 3309 on December 12, 1977, subject to conditions which will be satisfied at time of grading permit.

SECTION 3. The legal description of the property designated is attached as Appendix A and is hereby made a part of this ordinance. The above described property is shown on the attached map which is designated Appendix B and is hereby made a part of this ordinance. The development plan is designated Appendix C and is hereby made a part of this ordinance.

SECTION 4. As provided for in King County Zoning Code Resolution No. 25789, as amended, the King County Council does hereby grant the unclassified use permit
