AN ORDINANCE making an appropriation of \$33,596 from Federal Shared Revenue to the County Administrator's Office, and \$16,404 from Federal Shared Revenue and \$28,596 from unappropriated Current Expense Fund balance to Special Programs in the Current Expense Fund, for the purpose of establishing a Women's Program in King County; amending Ordinance No. 3492, Sections 9 and 40, as amended.

BE IT ORDAINED BY THE COUNCIL OF KING COUNTY:

SECTION 1. An appropriation of \$33,596 from Federal Shared Revenue to the County Administrator's Office for the purpose of funding the central staff of the Women's Program is hereby approved and adopted.

SECTION 2. Ordinance No. 3492, Section 9, is hereby amended to read as follows:

SECTION 3. An appropriation of \$16,404 from Federal Shared Revene and \$13,404 from unappropriated Current Expense Fund balance to Special Programs in the Current Expense Fund, to be divided equally among Green River Community College (\$7,500), Highline Community College (\$7,500), Shoreline Community College (\$7,500) and Bellevue Community College (\$7,500) for the purpose of conducting needs surveys for the Women's Program and executing the program for the balance of the year is hereby approved and adopted.

SECTION 4. An appropriation of \$15,000 from unappropriated Current Expense Fund balance to Special Programs in the Current Expense Fund, to be divided equally between Renton Vocational Technical Institute (\$7,500) and Lake Washington Vocational Technical Institute (\$7,500) is hereby approved and adopted. The funds shall be expended for the provision of direct training
