9 AN ORDINANCE amending King County Zoning Resolution
10 No. 25789, as amended, by amending the Zoning Map thereof
11 reclassifying certain property thereon at the request of
Ernest F. Iszley, Building and Land Development Division
File No. 265-77-R.

13 BE IT ORDAINED BY THE COUNCIL OF KING COUNTY:

14 SECTION 1. Ernest F. Iszley petitioned on July 21, 1977, that the property
15 described in Section 3 below be reclassified from SR to RM-1800 and this appli-
16 cation was assigned Building and Land Development Division File No. 265-77-R.

17 SECTION 2. The report and recommendation of the Building and Land Develop-
18 ment Division was transmitted to the Zoning and Subdivision Examiner on October 18,
19 1977, and hearing was held by the Examiner on the matter October 25, 1977. The
20 report of the Examiner was filed with the Clerk of the King County Council on
21 November 17, 1977.

22 SECTION 3. The legal description of the property to be reclassified is attached
23 as Appendix A and is hereby made a part of this ordinance. The above described
24 property is shown on the attached map which is designated Appendix B and is here-
25 by made a part of this ordinance.

26 SECTION 4. The King County Council does hereby amend King County Zoning
27 Code, Resolution No. 25789, as amended, by reclassifying that property described
28 and shown in Section 3, Appendices A and B above, to RD-3600 and directs that

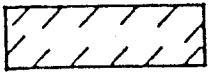
