ORDINANCE NO. 3654

AN ORDINANCE relating to the annexation of an area known as P-258 to Cascade Sewer District.

STATEMENT OF FACT:

1. A notice of intention proposing the annexation of an area known as P-258 to Cascade Sewer District was filed with the County Council effective February 23, 1977.

2. Cascade Sewer District has found the petition for annexation to be sufficient and has by Resolution 780, concurred with the proposed annexation.

3. Cascade Sewer District filed a Declaration of Nonsignificant Impact dated January 19, 1978, on the proposed annexation.

4. The County Council held a public hearing on the 3rd day of April, 1978, and has considered the criteria set forth in RCW 56.02.060.

BE IT ORDAINED BY THE COUNCIL OF KING COUNTY:

SECTION 1. The annexation by Cascade Sewer District of the area known as P-258 and described in Section 2 herein is approved.

SECTION 2. The area known as P-258 to be annexed is described as follows:

Beginning at the Southeast corner of the Northeast quarter of the Southwest quarter of Section 29, Township 23 North, Range 5 East, W.M., in King County, Washington, said point being on the existing boundary of Cascade Sewer District;

2 quarter to the Southerly extension of the Westerly line
3 of Lot 14, Block 4, Aker's Farms No. 5 as recorded in
Volume 40 of Plats, page 47, records of King County,
Washington;

4 Thence Northerly along said Southerly extension and
5 along the West line of Lots 14 through 23 inclusive,
6 and along the West line of Lot 25 of said Block 4 and
its Northerly extension to the centerline of Secondary
State Highway 5-C (Benson Road);

7 Thence Southeasterly along said centerline to the East
8 line of the Northwest quarter of said Section 29;

9 Thence Southerly along said East line to the Northwest
10 corner of the Southeast quarter of said Section 29;

11 Thence Easterly along the North line of the Northwest
12 quarter of said Southeast quarter to the East line
13 thereof;

14 Thence Southerly along said East line to the South line
15 of the North half of the South half of the Northwest
16 quarter of said Southeast quarter;

17 Thence Westerly along said South line to the West line
18 of said Southeast quarter, also being the East line of
19 the Southwest quarter of said Section 29;

20 Thence Southerly along said East line to the Point of
21 Beginning.
