ORDINANCE NO. 3658

AN ORDINANCE relating to flood hazards; establishing Flood Hazard Overzones along the Cedar, Raging, Snoqualmine, Tolt, Sammamish and Green Rivers and along Tibbets, Issaquah, Evans, Cottage Lake, Bear and Cherry Creeks; repealing Ordinances 1912, 1990, 2612 and substituting new sections therefor.

BE IT ORDAINED BY THE COUNCIL OF KING COUNTY:

SECTION 1. The lands along the Cedar River described below and shown on the zoning overlay maps attached hereto are hereby adopted as Flood Hazard Areas pursuant to the provisions of KCC 21.54 as now or hereafter amended:

The east 1/2 of Section 16; the east 1/2 of Section 21; Sections 22, 23 and 24 all in T.23N., R.5E., W.M.

Section 19; the west 1/2 of Section 20; the east 1/2 of Section 30, Sections 29, 32, and 33 all in T.23N., R.6E., W.M.

Township 22 North, Range 6 East, Willamette Meridian and the east 1/2 of Section 9, the west 1/2 of Section 10 and the east 1/2 of Section 16 all in T.22N., R.6E., W.M.

SECTION 2. The lands along Issaquah and Tibbets Creeks described below and shown on the zoning overlay maps attached hereto are hereby adopted as Flood Hazard Areas pursuant to the provious of KCC 21.54 as now or hereafter amended:

The west 1/2 of Section 15; Sections 10 and 3 all in T.23N., R6E., W.M.

The east 1/2 of Section 32; the east 1/2 of Section 29; the east 1/2 of Section 28; the west 1/2 of Section 27; Sections 20 and 21; the west 1/2 of Section 16 all in T.24N., R.6E., W.M.

SECTION 3. The lands along Evans, Cottage Lake and Bear Creeks desribed below and shown on the zoning overlay maps attached hereto are hereby adopted as Flood Hazard Areas pursuant to the provisions of KCC 21.54 as now or hereafter amended:

Sections 6 and 7, the west 1/2 of Section 8, Sections 16 and 17, the east 1/2 of Section 18, the east 1/2 of Section 21 and Section 22 all in T.25N., R.6E., W.M.

The east 1/2 of Section 19, the west 1/2 of Section 20, the west 1/2 of Section 29, Sections 30 and 31 all in T.26N., R.6E., W.M.

The east 1/2 of Section 1, the east 1/2 of Section 11 and Section 12 all in T.25N., R.5E., W.M.

SECTION 4. The lands along the Sammamish River described below and shown on the zoning overlay maps attached hereto are hereby adopted as Flood Hazard Areas pursuant to the provisions of KCC 21.54 as now or hereafter amended:

Section 12 T. 26N., R. 4E., W.M.

The west 1/2 of Section 7, the west 1/2 of Section 18 both in T.25N., R. 6E., W.M.

The east 1/2 of Section 11, Sections 12 and 13, the east 1/2 of Section 14 all in T.25N., R.5E., W.M.

The west 1/2 of Section 7, the east 1/2 of Section 8, Section 9, the west 1/2 of Section 10, Section 15, the east 1/2 of Section 16, the east 1/2

of Section 22, the west 1/2 of Section 23, the west 1/2 of Section 26, the east 1/2 of Section 27, the west 1/2 of Section 35 all in T. 26N., R. 5E., W.M. within section 8 & 9, Township 26, Range 5 East all land which is above the 100 year floodplain elevation of the Sammamish River or which is protected from backup from the Sammamish River shall not be part of the flood fringe or floodplain.

SECTION 5. The lands along Cherry Creek, the Snoqualmie, Tolt and Raging Rivers, including the North, Middle and South Forks of the Snoqualmie River described below and shown on the zoning overlay maps attached hereto are hereby adopted as Flood Hazard Areas pursuant to the provisions of KCC 21.54 as now or hereunder amended:

The east 1/2 of Township 26 North, Range 6 East, Willamette Meridian, and the west 1/2 of Section 11, the east 1/2 of Section 15 and the west 1/2 of Section 26 all in T.26N., R.6.E., W.M.

The west 1/2 of Township 26 North, Range 7 East, Willamette Meridian.

Section 1 and the east 1/2 of Section 12 both in T.25N., R.6E., W.M.

Township 25 North, Range 7 East, Willamette Meridian.

Township 24 North, Range 7 East, Willamette Meridian, and the west 1/2 of Section 14 and Section 15 both in T.24N., R.7E., W.M.

Township 23 North, Range 7 East, Willamette Meridian.

Township 24 North, Range 8 East, Willamette Meridian, and the west 1/2 of Section 32 in T.24N., R.8E., W.M.

Township 23 North, Range 8 East, Willamette Meridian, and the west 1/2 of Section 13 in T.23N., R. 8E., W.M.

Township 23 North, Range 9 East, Willamette Meridian.
