ORDINANCE NO. 3665

AN ORDINANCE relating to the annexation of an area known as Lake Youngs Way to King County Water District No. 58.

STATEMENT OF FACT:

1. A notice of intention proposing the annexation of an area known as Lake Youngs Way to King County Water District No. 58 was filed with the County Council effective March 7, 1978.

2. King County Water District No. 58 has found the petition for annexation to be sufficient and has, by Resolutions 1668 and 1669, concurred with the proposed annexation.

3. King County Water District No. 58 filed a Declaration of Nonsignificant Impact dated February 14, 1978, on the proposed annexation.

4. The County Council held a public hearing on the 10<sup>th</sup> day of April, 1978, and has considered the criteria set forth in RCW 57.02.040.

BE IT ORDAINED BY THE COUNCIL OF KING COUNTY:

SECTION 1. The annexation by King County Water District No. 58 of the area known as Lake Youngs Way and described in Section 2 herein is approved.

SECTION 2. The area known as Lake Youngs Way to be annexed is described as follows:

Beginning at the Northeast corner of the Southwest quarter of Section 3, Township 22 North, Range 5 East, W.M., King County, Washington, said point being on the existing boundary of Water District No. 58.

Thence Southerly along the East line of said Southwest quarter of a distance of 555.47 feet;

Thence Westerly along a line which lies 555.47 feet South of and parallel to the North line of said Southwest quarter a distance of 260 feet;

Thence Southerly along a line which lies 260 feet West of and parallel to the East line of said Southwest quarter a distance of 510 feet;

Thence Easterly along a line which lies 1065.47 feet South of and parallel to the North line of said Southwest quarter a distance of 260 feet to the East line thereof;

Thence Southerly along said East line to the South line of the Northeast quarter of said Southwest quarter;

Thence Westerly along said South line to the West line of the Northeast quarter of said Southwest quarter;

Thence Northerly along said West line and along the West line of the Southeast quarter of the Northwest quarter of said Section 3 to the South line of the North half of said Southeast quarter of the Northwest quarter;

Thence Easterly along said South line to the West line of the East quarter of the East half of the West half of said Section 3;

Thence Southerly along said West line to the North line of the Southwest quarter of said Section 3;

Thence Easterly along said North line to the point of beginning.
