ORDINANCE NO. 3673

AN ORDINANCE relating to traffic control; prohibiting parking at all times, establishing a passenger curb loading zone and establishing limit on parking time in the vicinity of Redondo Beach Drive South, repealing King County Ordinance No. 3166, and amending King County Ordinance No. 1100, Schedules 14, 16, 17 and 19.

BE IT ORDAINED BY THE COUNCIL OF KING COUNTY:

SECTION 1. King County Ordinance No. 3166 is hereby repealed.

SECTION 2. Pursuant to requests by local residents and investigations by the Department of Public Works and the Department of Public Safety, King County Ordinance No. 1100, Schedule 14, which prohibits parking at all times along county roads is amended, as authorized by King County Traffic Code 46.61.570-5, to add the following locations:

South 281st Street, on both sides between 10th Avenue South and Redondo Beach Drive South;

South 280th Street, on both sides from the centerline of Redondo Beach Drive South to a point 60 feet east of said centerline.

SECTION 3. King County Ordinance No. 1100, Schedule 16, which prohibits stopping, standing or parking during specified hours along county roads is amended, as authorized by King County Traffic Code 46.61.570-7, to add the following location:

Redondo Beach Drive South, on the west side from the north side of South 280th Street to a point 100 feet north of the centerline of South 282nd Street, and the east side between South 281st Street to 280th Street;

stopping, standing or parking is prohibited at all times.

SECTION 4. King County Ordinance No. 1100, Schedule 17, which limits parking time along county roads is amended, as authorized by King County Traffic Code 46.61.570-8, to add the following location:

South 280th Street, on the south side from a point 60 feet east of the centerline of Redondo Beach Drive South to a point 90 feet east of said point;

1 parking is limited to ten minutes.

2 SECTION 5. King County Ordinance No. 1100, Schedule 19,
3 which establishes passenger curb loading zones along county roads
4 is amended, as authorized by King County Traffic Code 46.61.575-4,
5 to add the following location:

6 Redondo Beach Drive South, on the west side from the
7 centerline of South 282nd Street to a point 100 feet
8 north of said centerline.

9 SECTION 6. Signs to evidence the above described
10 restrictions shall be installed by the proper authority.
