ORDINANCE NO. 3772

AN ORDINANCE relating to the annexation of an area known as P-259 to Cascade Sewer District.

STATEMENT OF FACT:

- 1. A notice of intention proposing the annexation of an area known as P-259 to Cascade Sewer District was filed with the County Council effective May 17, 1978.
- 2. Cascade Sewer District has found the petition for annexation to be sufficient and has, by Resolution 819, concurred with the proposed annexation.
- 3. Cascade Sewer District filed a Declaration of Nonsignificant Impact dated April 20, 1978, on the proposed annexation.
- 4. The County Council held a public hearing on June 19, 1978, and has considered the criteria set forth in RCW 56.02.060.

BE IT ORDAINED BY THE COUNCIL OF KING COUNTY:

SECTION 1. The annexation by Cascade Sewer District of the area known as P-259 and described in Section 2 herein is approved.

SECTION 2. The area known as P-259 to be annexed is described as follows:

Beginning at the Northwest corner of the Southeast quarter of the Northwest quarter of Section 34, Township 23 North, Range 5 East, W.M.; said point being on the existing boundary of Cascade Sewer District;

Thence Easterly along the North line of said subdivision to the North-South centerline of said Section 34;

Thence Southerly along said North-South centerline to the Westerly extension of the Southerly margin of the Plat of Carriage Lane Division No. 1 as recorded in volume 75 of Plats, page 8, records of King County, Washington;

Thence Easterly along said Westerly extension and along the Southerly margin of Carriage Lane Division No. 1 and along the Southerly margin of Carriage Lane Division No. 2 as recorded in Volume 76 of Plats, page 94, records of said County to the Westerly margin of Carriage Lane Division No. 3 as recorded in Volume 80 of Plats, pages 3 & 4, records of said County;

Thence Southerly along said Westerly margin and its Southerly extension to the East-West centerline of said Section 34;

Thence Westerly along said East-West centerline to the North-South centerline of said Section 34;

Thence Southerly along said North-South centerline to the South line of said Section 34;

Thence Westerly along said South line to the West line of the East half of the West half of said Section 34;

Thence Northerly along said West line to the Northwest corner of the Southeast quarter of the Northwest quarter of said Section 34 and the Point of Beginning.
