ORDINANCE NO. 3806

AN ORDINANCE making an additional appropriation of \$50,000 to the Federal Shared Revenue Fund from unappropriated interest earnings and appropriating \$50,000 to the Building Modernization Construction Fund for the construction of the Federal Way Courthouse Project from the Federal Shared Revenue Fund; amending and revising the King County 1978 Capital Improvement Budget and Programs and amending Ordinance No. 3492, Sections 57 and 73, Attachment No. 1, as amended.

BE IT ORDAINED BY THE COUNCIL OF KING COUNTY:

SECTION 1. There is hereby approved and adopted an additional appropriation in the amount of \$50,000 to the Federal Shared Revenue Fund to subsidize the construction of the Federal Way Courthouse, C.I.P. Project No. 002069.

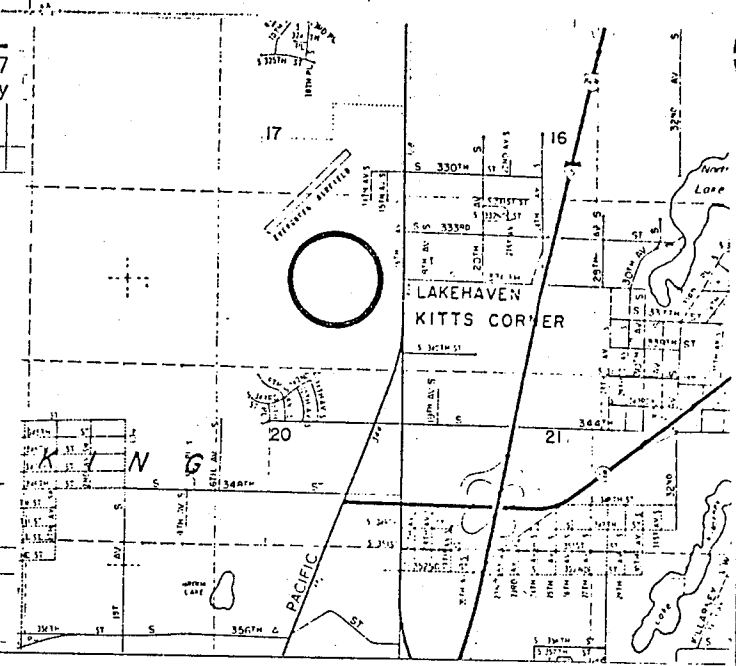
