30th LEGISLATIVE DISTRICT - 9th COUNCIL DISTRICT

That BELMOR and LAKEHAVEN Precincts shall be altered and a new Precinct BELMOR PARK, shall be created from them in the following described manner:

Beginning at the intersection of the centerline of South 320th Street and the west margin of Interstate Highway 5; thence southerly along the west margin of Interstate Highway 5 to its intersection with the centerline of 24th Avenue South; thence northerly along the centerline of 24th Avenue South and its northerly extension to its intersection with the centerline of Burning Tree Boulevard; thence northerly along the centerline of Burning Tree Boulevard to its intersection with the easterly extension of the southerly line of Lot 182 of Belmor Mobile Home Park; thence westerly along said easterly extension and along the south line of Lot 182 thru Lot 166 of said plat and along the southwesterly extension of the south line of Lot 166 to its intersection with the centerline of Pebble Beach Circle; thence northerly along the centerline of Pebble Beach Circle and its northerly extension to its intersection with the centerline of South 324th Street; thence westerly along the centerline of South 324th Street to its intersection with the centerline of Pacific Highway South; thence northerly along the centerline of Pacific Highway South to its intersection with the centerline of South 320th Street; thence easterly along the centerline of South 320th Street to its intersection with the west margin of Interstate Highway 5 and the Point of Beginning.
