5 ORDINANCE NO: 3825

6 AN ORDINANCE approving a portion of the Sewer
7 General Comprehensive Plan for the N.E. Lake
8 Washington Sewer District and declaring an
9 emergency.

9 PREAMBLE:

10 N.E. Lake Washington Sewer District adopted a Comprehensive
11 Plan by Resolution No. 1977-6-8 on July 21, 1977.

12 N.E. Lake Washington Sewer District filed a Declaration of
13 Non-significance on January 20, 1978.

14 The N.E. Lake Washington Sewer District Comprehensive Plan was
15 reviewed by the Utilities Technical Review Committee as re-
16 quired by KCC 13.24. On October 13, 1977, the UTRC recommended
17 approval of the plan, subject to conformance with the North-
18 shore Communities Plan. Ordinance No. 3579 passed January 30,
19 1978, approved portions of the Sewer General Comprehensive
20 Plan of N.E. Lake Washington Sewer District and called for the
21 preparation of a County Sewerage General Comprehensive Plan
22 to be prepared and adopted.

23 A portion of the district identified within the boundaries of
24 ULID #35 is developed with single family residences and is
25 experiencing health problems due to septic tank failures as
26 evidenced by a letter of the King County Health Department
27 dated June 28, 1978.

28 N.E. Lake Washington Sewer District has established the ULID
29 #35 and is prepared to implement the construction of sewers to
30 address the health problem.

31 BE IT ORDAINED BY THE COUNCIL OF KING COUNTY:

SECTION 1. The portion of the N.E. Lake Washington Sewer
District Sewer Comprehensive Plan within the boundaries of ULID
#35 is hereby approved.

SECTION 2. "The County Council finds as a fact and declares
that an emergency exists and that this ordinance is necessary for
the immediate preservation of public peace, health or safety or
