AN ORDINANCE amending King County Zoning Resolution No. 25789, as amended, by amending the Zoning Map thereof reclassifying certain property thereon at the request of Rembold Corporation, Building and Land Development Division File No. 122-77-R.

BE IT ORDAINED BY THE COUNCIL OF KING COUNTY:

Rembold Corporation petitioned on February 16, SECTION 1. 12 1977, that the property described in Section 3 below be reclassified from RS 7200 (Potential RD 3600) to RD 3600 and this application was assigned Building and Land Development Division File No. 122-77-R.
