ORDINANCE NO.

AN ORDINANCE amending King County Zoning Resolution No. 25789, as amended, by amending the Zoning Map thereof reclassifying certain property thereon at the request of Gary Maxfield, Building and Land Development File No. 125-78-R.

BE IT ORDAINED BY THE COUNCIL OF KING COUNTY:

SECTION 1. Gary Maxfield petitioned on January 3, 1978, that the property described in Section 3 below be reclassified from RS 7200 (Potential RM 2400) to RM 1800 and this application was assigned Building and Land Development Division File No. 125-78-R.

SECTION 2. The report and recommendation of the Building and Land Development Division was transmitted to the Zoning and Subdivision Examiner on March 2, 1978, and hearing was held by the Examiner on the matter March 9, 1978. The report of the Examiner was filed with the Clerk of the King County Council on April 7, 1978, and the Council approved the reclassification by Motion No. 03463 on April 17, 1978, subject to conditions which will be satisfied per the "P" suffix.

SECTION 3. The legal description of the property to be reclassified is attached as Appendix A and is hereby made a part of this ordinance. The above described property is shown on the attached map which is designated Appendix B and is hereby made a part of this ordinance.
