ORDINANCE NO.

AN ORDINANCE amending King County Zoning Resolution No. 25789, as amended, by amending the Zoning Map thereof reclassifying certain property thereon at the request of North City Lumber Company, Inc., B ing and Land Development Division File No. 132-78-R.

BE IT ORDAINED BY THE COUNCIL OF KING COUNTY:

SECTION 1. North City Lumber Company, Inc. petitioned on January 11, 1978, that the property described in Section 3 below be reclassified from B-C to C-G and this application was assigned Building and Land Development Division File No. 132-78-R.

The report and recommendation of the Building and SECTION 2. 17 Land Development Division was transmitted to the Zoning and Sub-18 division Examiner on April 6, 1978, and hearing was held by the 19 Examiner on the matter April 13, 1978. The report of the Examiner 20 was filed with the Clerk of the King County Council on May 12, 1978, 21 and the Council approved the reclassification by Motion No. 03521 22 on May 22, 1978, subject to conditions which will be satisfied per 23 the "P" suffix.
