AN ORDINANCE amending King County Zoning Resolution No. 25789, as amended, by amending the Zoning Map thereof reclassifying certain property thereon at the request of Parkwood Corporation, et al, Building and Land Development Division File No. 133-78-R.

BE IT ORDAINED BY THE COUNCIL OF KING COUNTY:

SECTION 1. Parkwood Corporation, et al petitioned on

January 13, 1978, that the property described in Section 3 below be

reclassified from RS 15,000 to SE and this application was assigned

Building and Land Development Division File No. 133-78-R.

SECTION 2. The report and recommendation of the Building and

Land Development Division was transmitted to the Zoning and Subdivi-

sion Examiner on April 6, 1978, and hearing was held by the Examin-

er on the matter April 13, 1978. The report of the Examiner was

filed with the Clerk of the King County Council on May-5, 1978, and

the Council approved the reclassification by Motion No. 03509 on

May 15, 1978.



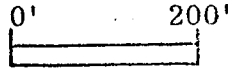

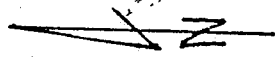
