SECTION 1. H. O. Meyer petitioned on December 30, 1977, that the property described in Section 3 below be reclassified from SE to MP and this application was assigned Building and Land Development Division File No. 123-78-R.

The report and recommendation of the Building and 17 | Land Development Division was transmitted to the Zoning and Sub-18 division Examiner on March 2, 1978, and hearing was held by the 19 Examiner on the matter March 9, 1978 and May 11, 1978. 
