3937 ORDINANCE NO.

AN ORDINANCE amending King County Zoning Resolution No. 25789, as amended, by amending the Zoning Map thereof reclassifying certain property thereon at the request of Pacific Rim Group, Inc., Building and Land Development Division File No. 259-78-R.

BE IT ORDAINED BY THE COUNCIL OF KING COUNTY:

SECTION 1. Pacific Rim Group, Inc. petitioned on March 20, 1978, that the property described in Section 3 below be reclassified from RS 7200 and RM 2400 to BC and this application was assigned Building and Land Development Division File No. 259-78-R.

The report and recommendation of the Building and Land Development Division was transmitted to the Zoning and Subdivision Examiner on June 15, 1978, and hearing was held by the Examiner on the matter June 22, 1978. The report of the Examiner was filed with the Clerk of the King County Council on July 17, 1978, and the Council approved the reclassification by Motion No. 03624 on July 24, 1978, subject to conditions which will be satisfied per the "P" suffix.

The legal description of the property to be reclassified is attached as Appendix A and is hereby made a part of this ordinance. The above described property is shown on the attached map which is designated Appendix B and is hereby made a part of this ordinance.

The King County Council does hereby amend King SECTION 4. County Zoning Code, Resolution No. 25789, as amended, by reclassifying that property described and shown in Section 3, Appendices A
