BE IT ORDAINED BY THE COUNCIL OF KING COUNTY:

SECTION 1. Ordinance 2596, Sections 1 and 2, as amended, and KCC 2.24.150 are hereby amended as follows:

a) The Director of the Department of Public Health is authorized and directed to make a charge for the provision of family planning services and supplies. These services can include, but are not limited to, a physical examination, urine examination, hematocrit, and birth control consultation.
