AN ORDINANCE relating to the annexation of an area known as Annexation #69-12 to Southwest Suburban Sewer District.

STATEMENT OF FACT:

- 1. A notice of intention proposing the annexation of an area known as Annexation #69-12 to Southwest Suburban Sewer District was filed with the County Council effective August 25, 1978.
- 2. Southwest Suburban Sewer District has found the petition for annexation to be sufficient and has, by Resolution 967, concurred with the proposed annexation.
- 3. Southwest Suburban Sewer District filed a Declaration of Nonsignificant Impact dated March 7, 1978, on the proposed annexation.
- 4. The County Council held a public hearing on September 25, 1978, and has considered the criteria set forth in RCW 56.02.060.

BE IT ORDAINED BY THE COUNCIL OF KING COUNTY:

SECTION 1. The annexation by Southwest Suburban Sewer

District of the area known as Annexation #69-12 and described in

Section 2 herein is approved.

SECTION 2. The area known as Annexation #69-12 to be annexed is described as follows:

That portion of Section 5, Township 22 North, Range 4 East, W.M. described as follows:

Beginning at the intersection of the centerline of 8th Avenue South and the easterly extension of the South line of Lots 6 and 7, Block 1, of Sierra Homes Addition No. 2, according to plat thereof recorded in volume 54 of plats, page 60, records of King County, Washington;

Thence Westerly Southerly and Westerly along the South line of said Block 1 and its Easterly extension, to the Southwest corner of said Block 1;

Thence Southerly along the Southerly extension of the West line of said Block 1 to its intersection with the North line of Sunny Glen, according to plat thereof recorded in Volume 64 of plats, page 26 records of King County, Washington;
