ORDINANCE NO. 3978

AN ORDINANCE relating to fees charged for the use of King County Swimming Pool Facilities.

BE IT ORDAINED BY THE COUNCIL OF KING COUNTY:

Section 1. All persons using King County owned and operated swimming pool facilities shall pay the service fees set forth in the following schedule, effective January 1, 1979:

## (1) Public and Adult Swims

PUBLIC SWIMS

YOUTH (17 yrs. & under) 45¢ per person per session.

ADULT (18 yrs. & older) 85¢ per person per session.

FIFTEEN CENT SWIMS - All ages - 15¢ per person per session.

ADULT ONLY SWIMS 85¢ per person per session.

SENIOR CITIZENS 25¢ per person for any program session.
