ORDINANCE NO.

AN ORDINANCE amending King County Zoning Resolution No. 25789, as amended, by amending the Zoning Map thereof reclassifying certain property thereon at the request of Kenneth F. Wagner, et al, Building and Land Development Division File No. 161-78-R.

BE IT ORDAINED BY THE COUNCIL OF KING COUNTY:

SECTION 1. Kenneth F. Wagner, et al, petitioned on April 7, 1978, that the property described in Section 3 below be reclassified from SR to RM 1800 and this application was assigned Building and Land Development Division File No. 161-78-R.

The report and recommendation of the Building and SECTION 2. Land Development Division was transmitted to the Zoning and Subdivision Examiner on July 6, 1978, and hearing was held by the Examiner on the matter July 13, 1978. The report of the Examiner was filed with the Clerk of the King County Council on August 11, 1978, and the Council approved the reclassification by Motion No. 03684 on August 28, 1978, subject to conditions which will be satisfied per the "P" suffix.

The legal description of the property to be re-SECTION 3. classified is attached as Appendix A and is hereby made a part of this ordinance. The above described property is shown on the attached map which is designated Appendix B and is hereby made a part of this ordinance.

SECTION 4. The King County Council does hereby amend King County Zoning Code, Resolution No. 25789, as amended, by reclassifying that property described and shown in Section 3, Appendices A and B above, to RD 3600-P and directs that Area Map W 29-26-5 be
