AN ORDINANCE amending King County Zoning Resolution No. 25789, as amended, by amending the Zoning Map thereof reclassifying certain property thereon at the request of Robert H. Curry, et al, Building and Land Development Division File No. 163-78-R.

BE IT ORDAINED BY THE COUNCIL OF KING COUNTY:

SECTION 1. Robert H. Curry, et al petitioned on April 7, 1978, that the property described in Section 3 below be classified from BC and RS 9600 (Potential RM 2400) to RM 2400 and this application was assigned Building and Land Development Division File No. 163-78-R.
