5 ORDINANCE NO. 4005

6 AN ORDINANCE amending King County Zoning Resolution
7 No. 25789, as amended, by amending the Zoning Map
8 thereof reclassifying certain property thereon at
the request of Wilson S. Graves, Building and Land
Development Division File No. 124-78-R.

9 BE IT ORDAINED BY THE COUNCIL OF KING COUNTY:

10 SECTION 1. Wilson S. Graves petitioned on December 30, 1977,
11 that the property described in Section 3 below be reclassified from
12 SR to RM 900 and this application was assigned Building and Land
13 Development Division File No. 124-78-R.

14 SECTION 2. The report and recommendation of the Building and
15 Land Development Division was transmitted to the Zoning and Subdi-
16 vision Examiner on March 2, 1978, and hearing was held by the Ex-
17 aminer on the matter March 9, 1978. The report of the Examiner
18 was filed with the Clerk of the King County Council on June 30,
19 1978, and the Council approved the reclassification by Motion No.
20 03723 on September 11, 1978, subject to conditions which will be
21 satisfied per the "P" suffix.

22 SECTION 3. The legal description of the property to be re-
23 classified is attached as Appendix A and is hereby made a part of
24 this ordinance. The above described property is shown on the at-
25 tached map which is designated Appendix B and is hereby made a part
26 of this ordinance.

27 SECTION 4. The King County Council does hereby amend King
28 County Zoning Code, Resolution No. 25789, as amended, by reclassi-
29 fying that property described and shown in Section 3, Appendices
30 A and B above, to RM 1800-P and directs that Area Map E 33-26-5 be
31 modified to so designate.

1 SECTION 5. This reclassification is granted subject to con-
2 ditions adopted in Motion No. 03723 and said conditions are incor-
3 porated herein as though fully set forth herein.
