AN ORDINANCE amending King County Zoning Resolution No. 25789, as amended, by amending the Zoning Map thereof reclassifying certain property thereon at the request of Frederick Lind, et al., Building and Land Development Division File No. 155-78-R.

BE IN ORDAINED BY THE COUNTY OF KING COUNTY:

SECTION 1. Frederick Lind, et al. petitioned on March 15, 1978, that the property described in Section 3 below be reclassified from SE to FR and this application was assigned Building and Land Development Division Fine No. 155-78-R.

SECTION 2. The report and recommendation of the Building and Land Development Division was transmitted to the Zoning and Subdivision Examiner on June 1, 1978, and hearing was held by the Examiner on the matter June 8, 1978. The report of the Examiner was filed with the Clerk of the King County Council on July 21, 1978, and the Council approved the reclassification by Motion No. 03638 on July 31, 1978.
