8 ORDINANCE NO. 4007

9 AN ORDINANCE amending King County Zoning
10 Resolution No. 25789, as amended, by amending
11 the Zoning Map thereof reclassifying certain
12 property thereon at the request of Frederick
13 Lind, et al., Building and Land Development
14 Division File No. 155-78-R.

15 BE IN ORDAINED BY THE COUNTY OF KING COUNTY:

16 SECTION 1. Frederick Lind, et al. petitioned on March 15,
17 1978, that the property described in Section 3 below be reclassi-
18 fied from SE to FR and this application was assigned Building and
19 Land Development Division File No. 155-78-R.

20 SECTION 2. The report and recommendation of the Building and
21 Land Development Division was transmitted to the Zoning and Sub-
22 division Examiner on June 1, 1978, and hearing was held by the
23 Examiner on the matter June 8, 1978. The report of the Examiner
24 was filed with the Clerk of the King County Council on July 21,
25 1978, and the Council approved the reclassification by Motion No.
26 03638 on July 31, 1978.

27 SECTION 3. The legal description of the property to be re-
28 classified is attached as Appendix A and is hereby made a part
29 of this ordinance. The above described property is shown on the
30 attached map which is designated Appendix B and is hereby made
31 a part of this ordinance.

SECTION 4. The King County Council does hereby amend King

1 County Zoning Code, Resolution No. 25789, as amended, by reclassi-
2 fying that property described and shown in Section 3, Appendices
3 A and B above, to FR and directs that Area Map 7-23-9 be modified
4 to so designate.
