ORDINANCE NO.

AN ORDINANCE amending King County Zoning Resolution No. 25789, as amended, by amending the Zoning Map thereof reclassifying certain property thereon at the request of Richard Dondero, Building and Land Development Division File No. 206-78-R.

BE IT ORDAINED BY THE COUNCIL OF KING COUNTY:

Richard Dondero petitioned on October 15, 1977, that the property described in Section 3 below be reclassified from BC to CG and this application was assigned Building and Land Development Division File No. 206-78-R.

The report and recommendation of the Building and Land Development Division was transmitted to the Zoning and Subdivision Examiner on January 17, 1978, and hearing was held by the Examiner on the matter January 26, 1978. The report of the Examiner was filed with the Clerk of the King County Council on February 24, 1978, and the Council approved the reclassification by Motion No. 03408 on March 6, 1978.
