AN ORDINANCE amending King County Zoning Resolution No. 25789, as amended, by amending the Zoning Map thereof reclassifying certain property thereon at the request of Frank E. Lamar & Edwin R. Bartholomew, Building and Land Development Division File No. 284-78-R.

BE IT ORDAINED BY THE COUNCIL OF KING COUNTY:

Frank E. Lamar and Edwin R. Bartholomew, petitioned on May 17, 1978, that the property described in Section 3 below be reclassified from RS 7200 (Potential RM 1800) to RM 1800 and this application was assigned Building and Land Development Division File No. 284-78-R.

The report and recommendation of the Building and SECTION 2. Land Development Division was transmitted to the Zoning and Subdivision Examiner on August 17, 1978, and hearing was held by the Examiner on the matter August 24, 1978.
