5 ORDINANCE NO. 4032

6 AN ORDINANCE amending King County Zoning
7 Resolution No. 25789, as amended, by amend-
8 ing the Zoning Map thereof reclassifying
9 certain property thereon at the request of
10 Frank K. McCarroll, Building and Land Develop-
11 ment Division File No. 268-78-R.

12 BE IT ORDAINED BY THE COUNCIL OF KING COUNTY:

13 SECTION 1. Frank K. McCarroll petitioned on March 31, 1978,
14 that the property described in Section 3 below be reclassified from
15 RS 7200 to RM 900 and this application was assigned Building and
16 Land Development Division File No. 268-78-R.

17 SECTION 2. The report and recommendation of the Building and
18 Land Development Division was transmitted to the Zoning and Sub-
19 division Examiner on July 20, 1978, and hearing was held by the
20 Examiner on the matter July 27, 1978. The report of the Examiner
21 was filed with the Clerk of the King County Council on August 18,
22 1978, and the Council approved the reclassification by Motion No.
23 03692 on August 28, 1978, subject to conditions which will be sat-
24 isfied per the "P" suffix.

25 SECTION 3. The legal description of the property to be re-
26 classified is attached as Appendix A and is hereby made a part of
27 this ordinance. The above described property is shown on the
28 attached map which is designated Appendix B and is hereby made a
29 part of this ordinance.

30 SECTION 4. The King County Council does hereby amend King
31 County Zoning Code, Resolution No. 25789, as amended, by reclassi-
fying that property described and shown in Section 3, Appendices
A and B above, to RM 900-P and directs that Area Map W 6-23-4 be

1 modified to so designate.

2 SECTION 5. This reclassification is granted subject to condi-
3 tions adopted in Motion No. 03692 and said conditions are incorpor-
4 ated herein as though fully set forth herein.
