AN ORDINANCE amending King County Zoning Resolution No. 25789, as amended, by amending the Zoning Map thereof reclassifying certain property thereon at the request of Vera Christianson, Building and Land Development Division File No. 228-78-R.

BE IT ORDAINED BY THE COUNCIL OF KING COUNTY:

Vera Christianson petitioned on December 30, 1977, SECTION 1. that the property described in Section 3 below be reclassified from RS 7200 to RM 900 and this application was assigned Building and Land Development Division File No. 228-78-R.
