AN ORDINANCE amending King County Zoning Resolution No. 25789, as amended, by amending the Zoning Map thereof reclassifying certain property thereon at the request of Edward J. Coury, Building and Land Development Division File No. 152-78-R.

BE IT ORDAINED BY THE COUNCIL OF KING COUNTY:.

Edward J. Coury petitioned on March 9, 1978, that the property described in Section 3 below be reclassified from RS 7200 to RM 1800 and this application was assigned Building and Land Development Division File No. 152-78-R.
