ORDINANCE NO. 4054

AN ORDINANCE amending King County Zoning Resolution No. 25789, as amended, by amending the Zoning Map thereof reclassifying certain property thereon at the request of Knoll Lumber & Hardware Company, Building and Land Development Division File No. 302-78-R.

BE IT ORDAINED BY THE COUNCIL OF KING COUNTY:

SECTION 1. Knoll Lumber & Hardware Company petitioned on August 16, 1978, that the property described in Section 3 below be reclassified from SR (Potential CG) and CG to CG and this application was assigned Building and Land Development Division File No. 302-78-R.

SECTION 2. The report and recommendation of the Building and Land Development Division was transmitted to the Zoning and Subdivision Examiner on October 5, 1978, and hearing was held by the Examiner on the matter October 12, 1978. The report of the Examiner was filed with the Clerk of the King County Council on November 9, 1978, and the Council approved the reclassification by Motion No. 03841 on November 13, 1978.

SECTION 3. The legal description of the property to be reclassified is attached as Appendix A and is hereby made a part of this ordinance. The above described property is shown on the attached map which is designated Appendix B and is hereby made a part of this ordinance.
